It should be further noted that the audit reports are to be submitted strictly as per the FORMAT which can be had from this office or any of the regional offices Gujarat Pollution Control Board before the last date prescribed in the Hon'ble High Court order dated 16-9-99. The different formats are sent to you & are also placed on GPCB website for your information & necessary action.

While carrying out the Environmental Audit of all industries of Schedule II you are directed to see that all the conditions of Hon'ble High Court order dated 20-12-96, 13-3-97 and 16/9/99 & also the guidelines issued by Gujarat Pollution Control Board in this regard; are complied with strictly failing which the Environmental Audit Report(s) may be liable for rejection.

You may apply a fresh three months before expiry of the recognition with the scrutiny fee of Rs. 20,000/- (Rs Twenty thousand only) to this Board, if you intend to renew your recognition.
